Dear Stakeholders.

This is to inform that the above Management Unit under the Parent Company FGV Holdings Berhad with RSPO membership number 1-0225-16-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit/Surveillance Audit (ASA-02) at Penggeli POM and its supply base, located at Johor, Malaysia. The audit will be conducted from 15 - 19 December 2025 against the requirements of:




